**Re: Compliance with European Parliament Directive 2011/65/EU - Restriction of Hazardous Substances (RoHS2 Directive) and Directive 2015/863/EU**

Dear Valued Paramount Extrusions Customer:

As you may be aware, the RoHS2 Directive took effect on July 21, 2011, and regulates member states of the European Union. One of its primary objectives is to address concerns related to certain hazardous substances that may be utilized in the manufacture of electrical and electronic equipment. Although we are not bound by the RoHS2 Directive, we provide this statement to customers who request our assistance in assessing their compliance with the RoHS2 Directive.

Based upon a good faith diligent inquiry, we do not have any reason to believe that our billet suppliers or internal cast houses intentionally add to the aluminum alloys we use any substances regulated by the RoHS2 Directive in effect as of the date of this statement in amounts more than the maximum concentration values.

We also do not have any reason to believe that our manufacturing process for mill finish extrusions, clear anodized extrusions, or painted products would result in any non-compliance with the RoHS2 Directive in effect as of the date of this statement. This certification applies to all amendments to the Directive as of the date of this letter, including 2015/863/EU. A list of chemicals subject to the directive is included as Attachment 1.

Should any additional alloys be introduced or any changes occur in the alloys used in our processes in the future, this document will be reviewed and updated accordingly to maintain continued compliance.
